





- Vores udgave af Zoom er et specialtilfælde, der ikke findes i tabellen
- > Alle cloud-løsningerne (på nær Signal) samler meta-data om brugeren
- Alle produkter som tillader at ringe ind fra GSM/PSTN telefoner har ikke endto-end kryptering
