Aktiviteten kort beskrevet	Task Force for Data Management at the Faculty of Health and Medical Sciences (SUND) at UCPH was commissioned to deliver a proposal for the faculty's data management policy.
Formål	RDM policy to comply with the Danish Code of Conduct for Research Integrity
Behov aktiviteten adresserer	The policy provides the framework for researchers to navigate through all elements of the data life cycle.
Nytte	Primary use for all researchers at the Faculty of Health and Medical Sciences at UCPH. As SUND was frontrunner in delivering a policy and members of the task force are engaged both in the UCPH reference group for data management and in the National Forum, intense knowledge transfer, synergies and sparring with other faculties and universities will occur. In addition, the policy serves as template for other institutions in Denmark.
